

JVSC1: A Bill to require all grocery stores in the USA to sell only low sugar products

Sponsored by Jude Proffitt

SECTION 1: Be it enacted that all grocery stores in the USA are required to only carry food and drinks with less than, for men 9 teaspoons (36 grams or 150 calories) of added sugar per day. For women, the number is lower: 6 teaspoons (25 grams or 100 calories) per day. (roughly one bottle of coke for both)

SECTION 2: This bill will be enforced by local grocery stores and markets throughout the USA.

SECTION 3: This bill will go into action immediately upon passing

SECTION 4: All laws or parts of laws in conflict with this bill are hereby declared null and void.

JVSC 2: A Bill to Buy Greenland
Sponsored by Senator Elliott Shetler

SECTION 1: Be it enacted by the Student Congress here assembled that the Federal government negotiate a price to buy Greenland from the Kingdom of Denmark.

SECTION 2: Greenland is located between the Arctic Ocean and the North Atlantic Ocean,
northeast of Canada and northwest of Iceland.

SECTION 3: Funding is required and will be taken from the Department of State's budget for the
fiscal year 2025. Funding will be negotiated with a price cap of \$50 billion.

SECTION 4: This bill will be enforced by Congress and the President and all other
necessary
bodies of government.

SECTION 5: Greenland will be bought in the beginning of fiscal year 2025 and the
funding will
be taken from the Department of State's budget that year.

SECTION 6: All laws or parts of laws in conflict with this bill are hereby declared null
and void.

**JVSC 3: A bill to ban public colleges from teaching politics in a bias standpoint.
Sponsored by Senator Fiona Hirschler.**

SECTION 1: Be it enacted that our US public colleges shall not teach politics in a Bias way, and if they are to teach politics, they shall teach them in a fair process. They shall not teach why or why not one is better, but in a fair way letting their students choose what they believe in. This will be observed by willing monitors.

SECTION 2: This bill will be enforced by Congress.

SECTION 3: This bill will go into effect immediately upon passing.

SECTION 4: If funding is needed for this bill all funding will be covered by the federal government.

SECTION 5: All laws or parts of laws in conflict with this bill are hereby declared null and void.

JVSC 4: A Bill To Fight Invasive Species
Sponsored by Senator Samuel Hawk

SECTION 1: Any U.S. citizen may capture any invasive species of fish, as defined by the U.S. Fish and Wildlife Service, on federal land without a fishing license or permit.

SECTION 2: (Capture) to take into one's possession or control by force. I would just like to make clear that any fish the U.S. Fish and Wildlife Service defines as an invasive species is what I referred to in my bill.

SECTION 3: No funding needed

SECTION 4: No enforcement needed

**JVSC 5: A bill to limit the number of terms a congress member may serve.
Sponsored by Josephine Proffitt**

SECTION 1: No person who has served six terms in the house of representatives will be eligible for reelection and able to serve a seventh term.

SECTION 2: No person who has served two terms as a Senator will be eligible for reelection and able to serve a third term.

SECTION 3: This will be enforced by The House of Representatives and The Senate.

SECTION 4: This will be enacted immediately upon passing and no former terms will be taken into consideration.

SECTION 5: This will not affect the Senate's rotational election.

JVSC 6: A Bill to Ban the Importation of Uranium from Russia
Sponsored by Senator Webster Shetler

SECTION 1: Be it enacted by the student congress here assembled that all imports of Russian low-enriched uranium shall be banned.

SECTION 2: This bill will be enforced by the United States Federal Government.

SECTION 3: No funding is required.

SECTION 4: This will be enacted beginning 90 days after this plan passes, with phaseout completed in 5 years.

SECTION 5: All laws or parts of laws in conflict with this bill are hereby declared null and void.

**JVSC 7: Bill: A Bill to Remove the Federal Minimum Wage
Sponsored by Senator Wade Shetler**

SECTION 1: Be it enacted by the Student Congress here assembled that the Federal Minimum Wage should be completely eliminated.

SECTION 2: Minimum wage will be defined as the lowest wage an employer can pay an hourly worker as established by the Fair Labor Standards Act (FLSA).

SECTION 3: No funding required.

SECTION 4: This bill will be enforced by the U.S. Department of Labor.

SECTION 5: This bill will be enforced at the beginning of the next fiscal year.

SECTION 6: All laws or parts of laws in conflict with this bill are hereby declared null and void.

JVSC 8: A bill to: ban Cocomelon
Sponsored by: bennett crandall

SECTION: 1. Be it enacted that the tv show Cocomelon will be banned from the united states of america (usa) and Moonbug Entertainment will no longer be allowed to make anymore episodes of Cocomelon.

and if they violate that rule they will have a fine of 1 million dollars.

JVSC 9: A Bill to Ban imports From China
Sponsored by Senator Oliver Parker

SECTION 1: Be it enacted that all imports from China to the US be banned

SECTION 2: Imports will be defined as goods sent from China to the United States.

SECTION 3: Funding will come from the federal government.

SECTION 4: This will be enforced by the federal government and any other necessary governing bodies.

SECTION 5: this will go into effect on January first 2029.

SECTION 6: All law or parts of laws in conflict with this bill will hereby be declared null and void.

**JVSC 10: A Bill to Ban the CAFE Standards for all Vehicles in the state of
Tennessee**

Sponsored by Senator Elijah Schrum

Section 1: Be it enacted that all CAFE standards for vehicles will be banned in the state of Tennessee

CAFE standards are banned in the state of Tennessee and the state will not recognize any Federal Law concerning CAFE standards

Section 2: Definitions -

CAFE: Corporate Average Fuel Economy

Ban: officially or legally prohibit

Section 3: No extra funding needed for this legislation

Section 4: This bill will be enforced by the Attorney General of the state.

Section 5: All laws or parts of laws in conflict with this bill are hereby declared null and void.

**JVSC 11: A bill to let dogs sit in fast food restaurants.
Sponsored by Bennett Crandall**

SECTION 1: be it enacted that dogs are allowed to sit under the table at fast food restaurants if they have a 3 foot leash or less on and are reasonably behaved.

SECTION 2: Fast food restaurants are those that serve food quickly.

SECTION 3: no funding required.

SECTION 4: no enforcement needed

SECTION 5: all laws in conflict with this bill will hereby be declared null & void

JVSC 12: A bill to promote music education for all students

Open for sponsorship

SECTION 1: Be it enacted that all children 10-18 shall join a choir, orchestra, or band for

at least one semester.

SECTION 2: Choir, orchestra, and band will be defined as any group with those respective

labels that meets at least once per week for a minimum of 14 weeks.

SECTION 3: This bill will be enforced by the department of education.

SECTION 4: This bill shall go into effect on January 1, 2025.

SECTION 5: Any laws in conflict with this bill are hereby declared null and void.

JVSC 13: A bill to increase the legal driving age in America

Open for sponsorship

SECTION 1: Be it enacted that the student congress here assembled should increase the

legal driving age to 18 years of age.

SECTION 2: This bill shall be enforced by the department of education.

SECTION 3: This bill shall go into effect on July 10th, 2024.

SECTION 4: All laws or parts of laws in conflict with this bill are hereby declared null and Void.

JVSC 14: A bill to require seatbelts on public school buses in America

Open for Sponsorship

SECTION 1: Be it enacted that seat belts will be required to be on all public school buses in

America

SECTION 2: This bill will be enforced by the US department of education

SECTION 3: This bill will be funded by federal governments in each districts where they will be

required to distribute grants

SECTION 4: This plan shall go into effect immediately upon passing

SECTION 5: All laws in conflict with this bill will hereby be declared null and void

JVSC 15: A Bill To Require The State of Tennessee to pay for any damages to cars due to potholes.

Open for Sponsorship

SECTION 1: Be it enacted that the state government will be required to compensate/pay for any

damage to cars due to potholes as long as it is reported within 6 months of it happening

SECTION 2: This bill will be enforced by TDOT - tennessee department of transportation

SECTION 3: This bill will be funded by cuts in the public education funding

SECTION 4: This bill will go into effect December 1st, 2024.

SECTION 5: All laws in conflict with this bill will hereby be declared null and void.
